
TENDER FOR HIRING OF VEHICLE

1. Sealed tenders to hire Mahindra Utility / Tata 207 double cab Model Year **January 2017** & above in proper efficient running condition are invited by the undersigned on behalf of the Navodaya Vidyalaya Samiti by Principal, Jawahar Navodaya Vidyalaya, Amba, Partur Dist: Jalna. (If said Mahindra Utility / Tata 207 Double cab Model Year **January 2017** & above model is not available, Vidyalaya may proceed for Tata Sumo, Grande / Mahindra Scorpio, Bolero Plus.
2. Tender should be sent under strong sealed cover marked as “Tender for hiring of Vehicle” so as to reach the Principal Jawahar Navodaya Vidyalaya, Amba, Partur Dist. Jalna(M.S.)
3. The Tender will be opened in the office of the undersigned at Jawahar Navodaya Vidyalaya, Amba, Partur Dist. Jalna(M.S.) tentatively on 30/06/2019.
4. Tender shall be submitted in Part-II according to the terms and conditions specified in paragraph 1 to 24 below.

Terms & Conditions:

1. The Vehicle should carry 4 persons having a comfortable seat for carrying sick child in addition adequate space 10 quintals load. The Vehicle like Mahindra & Mahindra double cab diesel, Tata double cab diesel will be preferred.
2. The contract will be for a period of **two years**.
3. The rates should be quoted on **yearly basis for a period of 10 months** in a year.
4. The vehicle will be hired alongwith Driver from the owner/company.
5. The vehicle shall be hired on **24 hour basis** for a period of 10 months in a year (excluding vacation period i.e., May and June)
6. **JNVs will bear only the cost of diesel for the distance actually plied** for official use, on the basis of average consumption quoted by the tenderer. All other liabilities including wages of driver, oil and lubricants, maintenance, repair, replacement of parts and servicing, obligations on account of motor vehicle act and other related acts like labour laws, road tax insurance laws (like insurance of Vehicles in accident, theft, fire etc) shall be the sole responsibility of the owner.
7. Rates to be quoted on yearly basis for a period of 10 months in a year.
8. Payments will be made on a monthly basis by the Principal, Jawahar Navodaya Vidyalaya, Amba, Partur Dist. Jalna(M.S.) where the vehicle is taken on hire basis.
9. Vehicle will be parked in the Vidyalaya premises only.

10. The driver of the vehicle can be provided accommodation wherever possible. Driver of the vehicle will be allowed to avail mess facility for food purposes only on payment basis.
11. Maximum one day per month i.e. 10 days in year shall be permitted for maintenance/ servicing. The vehicle shall not be sent for repairs for more than **four days at a stretch**. Alternate vehicle shall be provided by the owner in case the non-availability is for the period exceeding the specified period mentioned above, Failure to provide alternate vehicle shall lead to recovery of actual hiring charges per day or Rs.1000/- per day, or which ever is higher.
12. Use of the Vehicle will be restricted to the State for which it is hired and for Vidyalaya purpose only.
13. The owner shall be responsible for efficient and diligent services. If the service is not found satisfactory, the Principal, JNV will be at liberty to cancel the contract any time without prior notice and any reason to the owner of the same.
14. The owner shall be responsible for proper conduct of the Driver. He will have to change the driver in case the driver's conduct being reported as improper by the Principal of the JNV. The Principal, JNV will be at liberty to cancel the contract on this ground also i.e., in case the conduct of the driver is found unsatisfactory without any prior notice of the same to the owner.
15. On acceptance of the tender Contract in the prescribed format shall be executed by the Owner of the vehicle on one part and the Principal, Jawahar Navodaya Vidyalaya, Amba, Partur Dist. Jalna(M.S.) on the other part.
16. **An Earnest Money of Rs. 10,000/- for each vehicle shall be deposited along with the Tender in the form of a Demand Draft drawn in favour of the Principal, Jawahar Navodaya Vidyalaya, Amba, Partur payable at Partur** which is refundable. In case the Tenderer after acceptance of the tender by the NVS does not comply with the terms and conditions the EMD will be forfeited.
17. There should not be any overwriting or corrections in the Tender. If a figure is to be amended, it should be neatly scored out, the revised figure written above and he same attested with full signature, date and stamp. In the absence of the attested signature the tender is liable to be rejected.
18. The NVS/Principal JNV reserves the right to accept or reject any or all the tenders received without assigning any reason.
19. The amount of Security Deposit of Rs. 20,000/- for each vehicle shall be deposited with the concerned JNV by the tenderer who is awarded the contract for the JNV concerned till the contract is terminated as a safeguard against non-compliance and other contractual obligations.
20. The rates quoted by the Owner of the vehicle shall be for a period of **two years from the date of signing the contract**.
21. A certificate of roadworthiness of each vehicle is to be produced from R.T.O. authority by the Owner.
22. The Driver engaged by the Owner of the vehicle must possess a valid Driving License for the type of vehicle. He will have to submit the valid Driving License along with Police verification certificate of Driver.
23. Tenders which do not comply with any of the above conditions are liable to be rejected.
